- a) You can find out whether your personal data has been processed,
- b) If your personal data has been processed, you can request information about it,
- c) You can learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- d) You can learn about the third parties to whom your personal data is transferred at home or abroad,
- e) In the event that your personal data is processed an incomplete or incorrect way, you can request correction of them,
- f) You can request the deletion or destruction of personal data within the framework of the conditions stipulated in Article 7 of the KVKK,
- g) You may request to be informed about the transactions carried out in accordance with clauses (e) and (f) and the third parties to whom personal data are transferred,
- h) You can object to the occurrence of a result against you by analyzing the processed data exclusively through automated systems, and
- i) If you are exposed to any damage due to the processing of your personal data in violation of the KVKK, you can request compensation for the damage to which you have been exposed.

In accordance with Article 13 of the KVKK, data owners must submit their requests in writing to our Company or by other methods determined by the Personal Data Protection Board ("Board"). In this context, applications to be made to our Company can be submitted to us free of charge by means of taking a printout after this form fills out and means of choosing one of the four methods written below.

Your applications submitted to us will be answered within thirty days from the date of receipt of your request by our Company, depending on the nature of the request in accordance with Article 13/2 of the KVKK. Our answers will be delivered to you in writing or electronically in accordance with Article 13 of the KVKK.
